
Terms & Conditions

Cost:

The cost of the 2010 Paris Couture Tour is \$5990.

Air Transportation:

Air transportation to and from Paris is the responsibility of the participant. You will need to be in Paris from Sunday, October 31 through Monday, November 8, 2010. Please arrange your flights accordingly. Once you've registered, Susan will provide information on transfers from the airport to our hotel. Private transportation to and from Charles de Gaulle Airport is included.

Hotel:

Eight (8) nights of accommodation will be provided. A full breakfast is included. The single room supplement is \$900.

Entrance Fees, Tickets, Group Meals:

Admission to all venues, instruction sessions, tours and meals listed above is included. All other meals are the responsibility of the individual.

Land Transportation:

All transportation within Paris when with the group is included.

Travel Documents:

U.S. citizens will need a valid passport.

Included in the Tour Price:

Private transport to and from Charles de Gaulle Airport; hotel (double occupancy) for 8 nights, from Sunday, October 31 through Monday, November 8, 2010, including a full breakfast and taxes; all transportation within Paris when with the group; all entry fees and tours when with the group; a welcome lunch at our hotel; a couture draping seminar; a day of instruction at Lesage; sight-seeing tickets; a farewell dinner.

Not Included in the Tour Price:

Passport fees, visa (non-U.S. citizen), personal and/or baggage insurance, excess baggage, meals, tours and entrance fees not specified in the itinerary, all items of a personal nature such as laundry, cleaning, telephone, and beverages. Wine, liquor, soft drinks, tips to porters, drivers and local guides, and any other items not specifically mentioned as included above and listed on the Terms and Conditions Page.

Deposit and Payments:

A deposit of \$990 will confirm your reservation. The balance of \$5000 is due by September 1, 2010. Failure to pay by this date may result in cancellation of your registration and forfeiture of your deposit. Deposits will be processed in order of receipt.

Cancellations and Refunds:

All cancellations, for any reason whatsoever, will be subject to a \$100 per person cancellation fee. Cancellation within 61-90 days prior to the tour will result in a forfeiture of 40% of the cost of the tour per person; within 31-60 days, 60%; within 15-30 days, 80%. Cancellation within 14 days or less will result in forfeiture of the entire cost of the tour. Trip cancellation insurance is strongly advised; medical insurance is required.

Responsibility:

Susan Khalje, Susan Khalje Couture and her agents in regard to travel, assume no liability for injury, damage, loss, accident, delay, or irregularity which may be occasioned, either by reason of defect in any vehicle, or through the acts of default of any company or person engaged in conveying the passenger or in carrying out the arrangements of the tour. They can accept no responsibility for losses or additional expenses due to delay or changes in services, sickness, weather, strikes, war, terrorist action, quarantine or other causes. All such losses or expenses will have to be borne by the participant as tour rates provide for arrangements only for the times stated. The right is reserved to substitute a hotel of similar quality. The right is reserved to make minor changes in the itinerary, and the right is reserved to cancel the tour prior to departure, in which case a full refund will constitute full settlement to the passenger. No refund will be made for any unused portion of the tour. All registrants will be required to sign a responsibility statement.

At the time of this writing, the price of the 2010 Paris Couture Tour has been calculated at an exchange rate of \$1.50US/E1. Should the exchange rate differ considerably at the time of the trip, a surcharge will be imposed.
